In order to address this growing epidemic, services are now being offered for victims and survivors through the Indigenous Crime Victims Services Referral and Resource Center.

## Supporting Service Providers

ICVSRRC provides support to tribal and urban service providers in provision of services to Indigenous Victims of crimes related to domestic violence, sexual assault, stalking, strangulation, sex-trafficking, dating violence, homicide, identity theft, cybercrime and other crimes in Washington State.

- Coordination and networking between agencies to provide holistic, wrap around services for indigenous populations
- Advocating on behalf of victims obtaining needed services and resources

- Collaborating and to serve as a liaison with local and state government agencies in providing tribal specific guidance and consultation that impact policies and services for Indigenous victims.
